The Environmental, Health, and Safety Committee (EH&S) undertakes product stewardship and worker safety initiatives, such as:

- Considerations for the sterilization of devices that contain batteries:
- Hazard communications on using and measuring EO;
- Considerations for the use of respirators in warehouses;
- Evaluating options for EO respirator cartridges;
- Industrial hygiene guidelines for OSHA compliance checklists;
- Materials compatibility; and
- "Lessons learned" for companies engaged in process safety management/process hazard analysis.

EOSA provides a forum for its members to ensure their interests are protected and their voices are heard on issues of concern. EOSA conducts communications outreach to local, state, federal, and international government entities. EOSA offers networking opportunities with others in the EO industry, allowing members to voice concerns and to lend advice, ideas, and support.
